<b>Subject Overview:</b>	The subject includes study of a selected area of law at an advanced level; the subject allows the student to engage in self-directed research, subject to the supervision of a member of staff with expertise in the student's field of inquiry.
<b>Learning Outcomes:</b>	The subject aims to enhance the student's capacity to undertake independent research. The student is required to plan his or her own research project with the supervisor's assistance, and to develop the research skills necessary to successfully complete the project.
<b>Assessment:</b>	5,000 word research assignment; As a hurdle requirement to successfully complete the subject students are required to attend one class on research techniques and methods or undertake an equivalent research and writing task.
<b>Prescribed Texts:</b>	None.
