Core Participation Requirements:	<p>The Melbourne Law School welcomes applications from students with disabilities. Students must possess behavioural and social attributes that enable them to participate in a complex learning environment. Students are required to take responsibility for their own participation and learning. They also contribute to the learning of other students in collaborative learning environments, demonstrating interpersonal skills and an understanding of the needs of other students. Assessment may include the outcomes of tasks completed in collaboration with other students. Subject Overview:	<p>This subject provides practical experience in which students support lawyers in public interest organisations in the delivery of legal services to the community. Students will undertake 12 days of clinical placement with a partner organisation in the community or government sector. On placement, and under supervision, students will utilise the legal knowledge and skills acquired during their degree to undertake work on legal issues with real clients, and in doing so, will be exposed to the realities of legal practice. The placement will be through regular, scheduled attendances throughout semester.</p> <p>Prior to commencing with their host organisation, students will participate in two days of intensive orientation to prepare for their placement, including learning new legal practice skills and about specific areas of law where relevant. This will be complemented by seminars during the placement period. In these seminars, students will reflect on their ongoing clinical experience. This combination of practical placement and academic support will allow students to consider and reflect on the broader contexts in which legal issues arise, the lawyer's role and relationship with the delivery of justice and contemporary developments in professional practice.</p> <p>A central component of the subject is that students critically reflect on their practical experience of public interest lawyering. The reflection serves several purposes. First, it gives students the opportunity to consider how the issues and ideas raised in the context of public interest lawyering are reflected in their practical experience in this area of law. On an individual level, it also provides students with the opportunity to reflect on their own use of legal skills, knowledge and approach to practice and consequently build on these skills, knowledge and competencies.</p>
Learning Outcomes:	<p>A student who successfully completes this subject will have a sophisticated insight into, and be able to reflect critically and meaningfully on:</p> <ul style="list-style-type: none"> # The practical and technical skills and ethical awareness needed to practise effectively in the public interest sector, including in the areas of research, advocacy, communication, file management and organisation; # The ethical questions which arise from practising public interest law; # The scope, composition, capacity, limits and challenges of the legal assistance sector in Australia; # The techniques of public interest lawyering and the differences between public interest lawyering and other forms of lawyering; # The capacity of law and lawyers to create social, economic and political change.
Assessment:	Attendance at all orientation and clinic sessions and satisfactory performance on placement (hurdle requirement); Oral presentation, in weeks 9-12 of semester (15%); Reflective journal (25%); Legal writing, at end of semester (60%). The due date of the above assessment will be available to students via the LMS.
