<b>Recommended Background Knowledge:</b>	Applicants without legal qualifications should note that subjects are offered in the discipline of law at an advanced graduate level. While every effort will be made to meet the needs of students trained in other fields, concessions will not be made in the general level of instruction or assessment. Most subjects assume the knowledge usually acquired in a degree in law (LLB, JD or equivalent). Applicants should note that admission to some subjects in the Melbourne Law Masters will be dependent upon the individual applicant's educational background and professional experience.

<b>Subject Overview:</b>	<p>Successfully implementing international law requires understanding its operation in local settings, which often involve complex cultural dynamics. Human rights enforcement, transitional justice strategies and humanitarian law interventions are all deeply embedded in politics of cultural formation and identity. This subject explores the pressing need to take a bottom-up approach to international law and contextualise it within local, regional and global cultural processes as well as situate it with respect to non-state actors such as non-government organisations (NGOs) and grassroots social movements. Issues will be explored through case studies, including the International Criminal Tribunals for Rwanda and the former Yugoslavia, current cases before the International Criminal Court, the World Social Forum and Global Justice Movement and the unfolding impact of the United Nations Declaration on the Rights of Indigenous Peoples, particularly in reference to Latin America. The lecturer is a leading scholar in human rights, global governance and the cultural politics of legal pluralism.</p> <p>Principal topics will include:</p> <ul style="list-style-type: none"> <li># Historical genealogies of 'culture' and 'human rights'</li> <li># The possibilities and limits of global governance</li> </ul>
