<b>Recommended Background Knowledge:</b>	Applicants without legal qualifications should note that subjects are offered in the discipline of law at an advanced graduate level. Most subjects assume the knowledge usually acquired in a degree in law (LLB, JD or equivalent). Applicants should note that admission to some subjects in the Melbourne Law Masters will be dependent upon the individual applicant's educational background and professional experience.

<b>Subject Overview:</b>	<p>The settlement of international disputes is a cornerstone of international relations. Recent complex disputes arising from the territorial and resource claims, trade, investment and peace and security have given rise to a range of concerns about the effectiveness of international law to deal with disputes. This subject, therefore, seeks to provide students with an expert understanding grounded in theory and practice of how international law applies to the settlement of disputes, and the integrated means and methods used by the international community in settling such disputes. The subject will focus on peaceful settlement of disputes as opposed to the use of force. It will examine the role of the United Nations (UN) and regional organisations, and international courts and tribunals in a range of contexts. <b>Learning Outcomes:</b>	The settlement of international disputes is a cornerstone of international relations.
