<b>Subject Overview:</b>	This subject focuses on the appraisal and use of research in clinical practice. Its purpose is to develop practitioners' confidence and skills in critical consumption of research and evaluation for use in the workplace. Topics covered include: overview of common research and evaluation methods and issues; Internet and library search skills to assist in preparing a literature review; the process of change and strategies for implementing change in a clinical environment. Students will examine research and evaluate findings on an issue identified from their own practice. They will conduct a comprehensive literature review on a clinical intervention in their own practice, evaluate the evidence on which the clinical intervention was based and then apply the findings to their own practice setting.
<b>Learning Outcomes:</b>	Students will be expected to be able to: <ul style="list-style-type: none"> <li># identify common research and evaluation methods and practices;</li> <li># develop literature search skills;</li> <li># critically review research reports;</li> <li># appraise research in relation to its value to clinical practice;</li> <li># apply research findings to clinical practice;</li> <li># develop research and evaluation skills;</li> <li># an understanding of the changing knowledge base in the specialist area;</li> </ul>
