Subject Overview:	<p>The subject focuses on the decisions, usually made by governments, which determine the present and future objectives underlying a country's health services and programs. The following topics will be covered:</p> <ul style="list-style-type: none"> # policy definitions and instruments; # ideas, ideologies and interests that influence priorities in policy decision making; # the significance of effectiveness, efficiency and equity as objectives of health policy; # legal, political, managerial, sociological and economic perspectives in understanding policy formation; and # the emerging role of scientific evidence in policy formation. 						

	Processes relating to the development and implementation of health policy including health policy analysis and monitoring and evaluation. Both Australia and developing country contexts will be studied.
