| Subject Overview:                       | This agency-based supervised placement subject provides an intensive practice learning experience. It provides students with opportunities for both professional learning and development and workplace preparation. Students will learn to integrate <i>advanced</i> theory with practice. They will further develop and consolidate practice skills, increase their knowledge of the interface between policy, research and evidence-based practice and increase their understanding of the organisational context of policy and practice. This subject requires students to attend university and agency-based preparation seminars, early placement seminars and integration seminars and complete the first 35 days of the first professional placement required within the MSW course. |                |                            |                |   |                               |       |
| Learning Outcomes:                      | The goal of this subject is to enable students to develop advanced social work practice and intervention skills and a higher level of competence on the key areas of learning. It includes opportunities to complete a placement which focuses on group work, community work, research, social policy and more specialised or intensive direct practice.
